SCHOOL FEES - 2023

Dear Parents/ Guardians and Sponsors

Parkview Senior School is a compulsory fee-paying public school. We are dependent on school fees in order to function properly. Our fees and fee policy are reviewed on an annual basis.

At the AGM held on 20th October 2022, a quorum of parents approved that the school will remain a compulsory fee-paying school. In terms of Section 39 of the South African Schools Act 84 of 1996, you are therefore liable to pay school fees.

The following 2023 fees, fee structure and resolutions, were unanimously adopted at the Annual General Meeting of 20 October 2022. The annual school fees per learner for the 2023 school year will be:

Grade 4-7 R34 100 and a Compulsory Book Fee R500/learner

- (c) By debit order in which event parents are requested to complete Annexure B Debit order form. **This must be completed annually.**
