## **SCHOOL FEES - 2023**

Dear Parents/ Guardians and Sponsors

Parkview Senior School is a compulsory fee-paying public school. We are dependent on school fees in order to function properly. Our fees and fee policy are reviewed on an annual basis.

We would like to thank all who have paid their fees regularly during 2022, by doing so you enable the school to provide a quality service to our learners.

At the AGM held on 20<sup>th</sup> October 2022, a quorum of parents approved that the school will remain a compulsory fee-paying school. In terms of Section 39 of the South African Schools Act 84 of 1996, you are therefore liable to pay school fees.

The following 2023 fees, fee structure and resolutions, were unanimously adopted at the Annual General Meeting of 20 October 2022. The annual school fees per learner for the 2023 school year will be:

### **PAYMENT OPTIONS**

The following payment options are available:

- (a) In cash to the school.
  - A cash deposit fee will be charged to the parent/guardian's account
  - Amounts over R500 must be deposited directly into the school's bank account and email proof of payment
- (b) By Direct Deposit into the school bank account – EFT or cash deposit (please note that cash deposit fees will be charged to the parent/guardians account)
- (c) By debit order - in which event parents are requested to complete Annexure B - Debit order form. **This must be completed annually.**
