Dear Parents/ Guardians and Sponsors

Parkview Senior School is a compulsory fee-paying public school. We are dependent on school fees in order to function properly. Our fees and fee policy are reviewed on an annual basis.

We would like to thank all who have paid their fees regularly during 2024; by doing so you enable the school to provide a quality service to our learners.

At the AGM held on 16th October 2024, a quorum of parents approved that the school will remain a compulsory fee-paying school. In terms of Section 39 of the South African Schools Act 84 of 1996, you are therefore liable to pay school fees.

The following 2025 fees, fee structure and resolutions, were unanimously adopted at the Annual General Meeting of 16 October 2024. The annual school fees per learner for the 2025 school year will be:

PAYMENT OPTIONS

The following payment options are available:

- (a) In cash to the school.
 - A cash deposit fee will be charged to the parent/guardian's account
 - Amounts over R500 must be deposited directly into the school's bank account and email proof of payment
- (b) By Direct Deposit into the school bank account – EFT or cash deposit (please note that cash deposit fees will be charged to the parent/guardians account)
- (c) By debit order - in which event parents are requested to complete Annexure B - Debit order form. **This must be completed annually.**

DISCOUNTS

1. Parents who settle their accounts in full, on or before 31 January 2025, will be entitled to a discount of R1400 per learner.
2. School fees paid via debit order will qualify for a discount of R750 per year per learner on successful debits over 10 consecutive months-discount eligibility will be end of October 2025.
